

## OFFICIAL RULES FOR THE “Find the Green Flag to Wave the Green Flag” ”

### **NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING**

**SWEEPSTAKES PERIOD:** Find the Green Flag to Wave the Green Flag (“Sweepstakes”) begins on February 01, 2017 at 12:01 a.m. Eastern Standard Time (“EST”) and ends on February 3, 2017 at 11:59 p.m. EST (the “Sweepstakes Period”).

Click the link on the page and follow the directions provided to complete the entry form and submit to receive one (1) entry into the Sweepstakes. All online entries must be submitted by February 3, 2017 at 11:59 p.m. EST to be eligible. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void.
