

OFFICIAL RULES FOR THE “NASCAR HEAT 4 GIVEAWAY”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: NASCAR Heat 4 Giveaway (“Sweepstakes”) begins on September 12, 2019 at 12:01 a.m. Pacific Standard Time (“PST”) and ends on September 19, 2019 at 11:59 p.m. PST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there is one (1) way to enter: visit https://tradablebits.com/tb_app/446495 and follow the directions provided to enter to win. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household. Entries received from any person or email address or household in excess of the limitation will be void. All entries become the sole property of the Sponsor. Released Parties (as defined below) are not responsible for lost, late, garbled, incomplete, delayed, illegible or misdirected entries. Incomplete, illegible, or fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction.
