

OFFICIAL RULES FOR THE “A GRAHAM RAHAL INDY 500 TICKET REFUND PROMOTION”

PROMOTION PERIOD: The “A GRAHAM RAHAL INDY 500 TICKET REFUND PROMOTION” (“Promotion”) begins on May 11, 2015 at 12:01am Central Standard Time (“CST”) and ends on May 24, 2015 at 9 a.m. PST (the “Promotion Period”) while supplies last. Sponsor reserves the right to end the Promotion early and shall post notification of such on its website.

HOW TO ENTER: Purchase a single day ticket in the reserved grandstand sections to the MAVTV 500 Verizon IndyCar Series race scheduled to be held at Auto Club Speedway June, 27, 2015 during the Promotion Period, you are eligible to have the ticket price refunded if Graham Rahal wins the INDY 500 scheduled to take place at Indianapolis Motor Speedway on May 24, 2015. Offers valid only on single day ticket purchases to the MAVTV 500 Verizon IndyCar Series race (no season, weekend, upgrades or any other ticket packages / purchases eligible). Tickets must be paid in full at the time of purchase to be eligible. Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. Incomplete, illegible, or fraudulent entries will be void.

ELIGIBILITY: Promotion is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction.
