

OFFICIAL RULES FOR “Social Giveaways at Auto Club Speedway”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: Social Giveaways (“Sweepstakes”) at Auto Club Speedway begins on February 16, 2018 at 12:01 p.m. Pacific Standard Time (“PST”) and ends on April 1, 2018 at 11:59 p.m. PST (the “Sweepstakes Period”).

Entrant must perform the specific action instructed by the respective Entry Post and include the hashtag #ACSContest, to be automatically entered into the Sweepstakes. Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. Limit one (1) entry per person, per day on each social media platform. Entries received from any person in excess of the limitation will be void. All entries become the sole property of the Sponsor and will not be returned. Fraudulent entries will be void.
