

## OFFICIAL RULES FOR THE “Renew To Win”

### NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

**SWEEPSTAKES PERIOD:** Renew To Win (“Sweepstakes”) begins on August 05, 2019 at 12:01 a.m. Eastern Standard Time (“EST”) and ends on August 23, 2019 at 11:59 p.m. EST (the “Sweepstakes Period”).

**HOW TO ENTER:** During the Sweepstakes Period, there are 2 ways to enter: (1) Renew your 2020 NASCAR Cup Series race tickets by mail, phone or website to receive one (1) entry into the Sweepstakes or (2) Via Mail: Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and date of birth on a 3" x 5" card and mail the card, with proper postage affixed to: Renew to Win Sweepstakes c/o California Speedway Corporation, 9300 Cherry Avenue, Fontana, CA 92335. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household. Entries received from any person or email address or household in excess of the limitation will be void.
