

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: The Victory Lane at Auto Club Speedway Sweepstakes (“Sweepstakes”) begins on [February 22, 2017 at 12:01 a.m. Eastern Standard Time \(“EST”\)](#) and ends on [March 17, 2017 at 11:59 p.m. EST](#) (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there are two (2) ways to enter: **(1) Online:** Visit www.autoclubspeedway.com/victorylane and follow the directions provided to complete the entry form and submit to receive one (1) entry into the Sweepstakes.
