

OFFICIAL RULES FOR THE “Hard Summer Giveaway”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: The Hard Summer Giveaway (“Sweepstakes”) at Auto Club Speedway begins on July 18, 2019 at 8 a.m. Pacific Standard Time (“PST”) and ends on July 30, 2019 at 5 p.m. PST (the “Sweepstakes Period”).
