

OFFICIAL RULES FOR THE “RV Experience at Auto Club 400”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: The RV Experience at Auto Club 400 (“Sweepstakes”) begins on October 4, 2019 at 10:00 a.m. Pacific Standard Time (“PST”) and ends on October 13, 2019 at 6:00 p.m. PST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there is one (1) way to enter: Visit the Auto Club Speedway display booth, located at the entrance gate during the California RV Show between 10:00 a.m. and 6:00 p.m. each day and follow the directions provided to enter to win. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household. Entries received from any person or email address or household in excess of the limitation will be void. All entries become the sole property of the Sponsor. Released Parties (as defined below) are not responsible for lost, late, garbled, incomplete, delayed, illegible or misdirected entries. Incomplete, illegible, or fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction.
