

OFFICIAL RULES FOR THE “ENTER TO WIN EXCLUSIVE ACCESS TO BUSCH BLOCK PARTY”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: Enter to Win Exclusive Access to Busch Block Party (“Sweepstakes”) begins on February 4, 2020 at 12:01 a.m. Eastern Standard Time (“EST”) and ends on February 14, 2020 at 11:59 p.m. EST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there is one (1) way to enter: **(1) Online:** via the website at <https://gleam.io/NYhqp/sunday-funday-at-nascar-enter-to-win-exclusive-access-to-busch-block-party> and follow the directions provided to complete the entry form and submit to receive one (1) entry into the Sweepstakes (“Entry”).

BONUS ENTRY(IES): After submitting an Entry, each entrant may obtain bonus entries during the Sweepstakes Period by completing the following for bonus entry methods (each a Bonus Offer):

Each entrant will click on the Sweepstakes link found on each social media platform and website and follow the instructions for the Bonus Entries. Each Bonus Offer will provide the number of Bonus Entries in the Sweepstakes specified in the Bonus Offer.

Entries and/or Bonus Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household. Entries and/or Bonus Entries received from any person or email address or household in excess of the limitation will be void.
